#### Mission Statement

The Delta Academy will provide a safe and nurturing instructional environment in which students from various backgrounds expand their knowledge base to fulfill academic and personal goals through differentiated instruction and reinforcement of positive character traits.

### **Principal's Highlights**

The Delta Academy is in its 5th year of operation. We continue to improvement our program while maintaining true to the mission through differentiated instruction and low student-to-teacher ratio.

- The Delta Academy has maintained a low student-to-teacher ratio. The average class ratio is 12 students to each teacher.
- The Delta Academy offers a traditional "brick and mortar" instructional model as well as an online instructional model.
- Weekly attendance, behavior and academic progress incentives have been put into place.
- The number of students graduating from the Delta Academy has more than doubled each year for the past 4 years.
- The Delta Academy offers affordable online summer school to all Clark County middle and high school students.
- In order to assist with student performance, we use Bright Arrow Communication as well as personal calls to communicate between home and school.
- The Delta Academy has seen a decrease in discipline referrals and suspensions in the 2011-2012 school year.
- The Delta Academy uses state-of-the-art thin client technology for its computer labs.

## **Goals and Objectives**

#### Goal 1

Students will improve their achievement in mathematics.

#### Objective(s):

Students in grade 11 will achieve the mathematics target of 71.3% or attain Safe Harbor (reduce non-proficient students by 10%) as measured by the March, 2012 mathematics NHSPE.

#### Goal 2

Increase student participation in the Criterion Referenced Tests (CRT) and NV High School Proficiency Exam (NHSPE.)

#### Objective(s):

Students in grades 7, 8, 10, 11, and 12 will achieve the participation target of 95% (or N-1 in the applicable subgroups) as measured by the CRT's and NHSPE.





# **Parent/Community Involvement**

We use the Bright Arrow Communication system for mass phone calls to disseminate important school-related information as well as to notify parents of student absences.
