Principal's Message

It is our pleasure to welcome you to Valley View Elementary School, home of the Mustangs, and our vibrant community of learners. Situated on a bluff overlooking the valley around us, Valley View first opened its classroom doors in 1960 and has had the privilege of educating generations of neighborhood families for more than fifty years.

The Valley View community illustrates what is possible when two unique programs work together as part of one school. Our English Only and Spanish Dual Immersion programs each serve roughly half our school population, and are strongly committed to equitable learning, academic excellence, and social development. We evaluate the student work and instructional delivery systems from these programs in light of the California state standards and frameworks, model curriculum guides and state compliance criteria.

Honored in 2003 with the CABE (California Association of Bilingual Education) Seal of Excellence and in 2006 as a California Distinguished School, Valley View continues to stand out as an example of student-centered focus and achievement. Our dedicated staff continually reassesses our outcomes and refines our teaching and learning practices around student success. Valley View's annual Academic Performance Index (API) scores clearly reflect the outstanding effort put forth by our students and teaching staff in making academic achievement the highest priority.

Our faculty and our School Site Council comprised of teachers, staff, and parents, reviews our site assessment data on an annual basis and develops our Single Plan for Student Achievement each year. Our main focus for this year will be equity for all learners and the narrowing of the achievement gap that exists for our diverse student population.

Our school community benefits from active parent and community participation in regular and special school activities. Early intervention tutors include parent volunteers who work with individual and small groups of students; our Go Green and Wellness Programs rely on parent volunteers who help with food scrapping, recycling, and school garden activities; and our Parent Faculty Club supports year-round fund-raising and community-gathering events. Visitors frequently share their delight about being welcomed as a part of the Valley View community. It is with that same enthusiasm and pride that we say to you, "Welcome to the View!"

We are a child centered, forward thinking learning community, educating each of our students in an individually appropriate manner within an environment of personal safety and mutual respect to become well informed, productive and socially responsible citizens.

School Profile

Valley View Elementary School is located in the eastern region of Pleasanton and serves students in grades kindergarten through five following a traditional calendar. At the beginning of the 2010-11 school year, 730 students were enrolled, including 9% in special education, 21% qualifying for English Language Learner support, and 19% qualifying for free or reduced price lunch. Valley View Elementary School achieved a 2011 Academic Performance Index (API) score of 899.

Student Achievement

Standardized State Assessments

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, ten, and eleven.

Student scores are reported as performance levels. Physical Fitness

In the spring of each year, Valley View Elementary School is required by the state to administer a physical fitness test to all students in grade five. The physical fitness test measures each student's ability to complete fitness tasks in six major areas. Students who either meet or exceed the standards in all six fitness areas are considered to be in the "healthy fitness zone." The chart disclosed in this document reports only the percentage in each category, not a cumulative total of the results for categories 4 of 6 and 5 of 6. Academic Performance Index

California uses the results of STAR testing to calculate the Academic Performance Index (API) which is used to measure school performance, set academic growth targets, and monitor progress over time. The API is a numeric index between 200-1000 that measures student performance in grades two through eleven. An API score of 800 is the state's designated performance target for all schools. Test results are weighted and a formula is applied to determine API.

Growth Targets: For schools with an API under 800, the state requires a gain of 5% of the difference between the school's actual API and 800. Growth Targets apply not only schoolwide, but to each numerically significant subgroup as well. Schools/subgroups that have achieved an API of 800 or above must maintain their scores.

Statewide Rank: All schools in California are categorized according to type (elementary, middle, high) and are placed on a scale of 1 to 10, with 10 being the highest.

Similar Schools Rank: School performance is also compared to other similar schools in the state, based on demographic characteristics, and ranked 1 to 10 within a grouping of 100 schools.

Adequate Yearly Progress

The Federal No Child Left Behind Act (NCLB) requires that all students perform at or above the proficient level on the state's standards-based assessment by the year 2014. Meeting Adequate Yearly Progress (AYP) milestones helps determine whether students are reaching proficiency level targets set by NCLB. AYP requires annual evaluation and reporting of the academic progress of all students and defined student subgroups.

For the 2010-11 AYP cycle, elementary and middle schools must achieve a 67.6% or higher proficiency rate in all subgroup populations for English/Language Arts and 68.5% or higher proficiency rate in math on the California Standards Test (CST). Additional criteria contributing to whether or not a school demonstrates AYP include achieving a 95% or above participation rate on the CST and obtaining an API growth score of 710 or increasing the API growth by 1 point.

No Child Left Behind (NCLB)

The No Child Left Behind (NCLB) Act is part of the Federal Title I funding program designed to support additional staffing and programs to meet the needs of low-income, low achieving students, and other designated students with special needs. Schools may apply, based upon their student demographics, for one of two types of Title I funding: Title I Schoolwide or Title I Targeted Assistance. Title I Schoolwide schools use federal funds for schoolwide improvement of student achievement. In 2010-11, Valley View Elementary School qualified for Title I Targeted Assistance funding and is subject to comply with Title I program requirements.

Any school receiving Title I funds is required to comply with respective program testing and reporting activities, achieve specific levels of student proficiency, and monitor school progress towards meeting established goals. California Adequate Yearly Progress calculations determine whether a Title I school has met performance goals. Schools not meeting specific AYP criteria enter Program Improvement, a monitoring system and curriculum enhancement program designed to help schools to increase student proficiency levels. School Facilities & Maintenance

The district takes great efforts to ensure that all schools are clean, safe, and functional through proper facilities maintenance and campus supervision. Valley View Elementary School's original facilities were built in 1960; ongoing maintenance and campus improvements ensure facilities remain up to date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority.

During 2010-11, a Fifty Year Anniversary campus beautification project spearheaded by Valley view's Parent Faculty Club resulting in many school improvements throughout the campus.

Every morning before school begins, the custodian inspects facilities for safety hazards or other conditions that need attention prior to students and staff entering school grounds. One day custodian and one evening custodian are assigned to Valley View Elementary School. The day custodian is responsible for:

- Classroom cleaning
- Cafeteria setup/cleanup
- Groundskeeping
- Office area cleaning
- Restroom cleaning

Restrooms are checked throughout the day for cleanliness and subsequently cleaned as needed. The evening custodian is responsible for:

- Classroom cleaning
- Office area cleaning
- Restroom cleaning

The principal communicates with custodial staff daily concerning maintenance and school safety issues.

Deferred Maintenance

Valley View Elementary School participates in the State School Deferred Maintenance Program, which provides dollar-for-dollar matching funds to assist school districts with major repairs or replacement of existing school building components. Facilities Inspection

The district's maintenance department inspects Valley View Elementary School on an annual basis in accordance with Education Code §17592.72(c)(1). Valley View Elementary School uses a school site inspection survey to identify unsafe or hazardous conditions and facility improvement needs. The most recent school inspection took place on Wednesday, September 07, 2011. No emergency repairs were needed and no unsafe conditions were found. During fiscal year 2010-11, all restrooms were fully functional and available for student use.

Rating Description

Exemplary: The school meets most or all standards of good repair. Deficiencies noted, if any, are not significant and/or impact a very small area of the school.

Campus Supervision

School administration and teaching staff place a high priority on providing adequate adult supervision on campus before, during, and after school. As students arrive on campus each morning, the principal and teaching staff are strategically assigned to designated entrance areas and the playground. The principal and noon supervisors monitor lunch time activity in the cafeteria and on the playground. At the end of the day when students are dismissed, the principal and teaching staff monitor student behavior to ensure a safe and orderly departure.

Valley View Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds.

School Site Safety Plan

The Comprehensive School Site Safety Plan was developed for Valley View Elementary School in collaboration with local agencies and the district office to fulfill Senate Bill 187 requirements. Components of this plan include child abuse reporting procedures, teacher notification of dangerous pupil procedures, disaster response procedures, procedures for safe arrival and departure from school, sexual harassment policy, and dress code policy. The school's most recent school safety plan was reviewed, updated, and discussed with school staff in January 2011.

Classroom Environment

Discipline & Climate for Learning

Valley View Elementary School's discipline practices and behavior management strategies comply with approved board policies and are designed to create effective learning environments and minimize classroom disruptions. Progressive discipline and proactive measures are employed in the classroom for those students experiencing difficulty following school rules and demonstrating positive behavior. Disciplinary intervention is managed by school administrators in a fair, firm, and consistent manner based upon the nature of each situation.

Curriculum & Instruction

Staff Development

All training and curriculum development activities at Valley View Elementary School revolve around the California State Content Standards and Frameworks. During the 2010-11 school year, Valley View Elementary School held staff development devoted to:

- The Achievement Gap (Diversity and Equity for all Learners)
- Writing Instruction
- Test-Taking Strategies
- Mathematics and Technology
- Student Wellness Programs
- Safe School Planning
- Study Island Online Tutorial Program
- Soul Shoppe Inservice and Assemblies
- English Language Development (ELD)

Decisions concerning selection of staff development activities are performed by all staff using tools such as teacher input, district benchmark results, and data analysis to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Valley View Elementary School supports ongoing professional growth throughout the year on minimum days. Teachers meet in grade level teams to conduct data analysis to identify areas of need.

Valley View Elementary School offers support to new and veteran teachers through peer coaching and mentoring. Instructional aides are provided targeted training focused on teaching strategies and curriculum content. Substitute teachers are invited to participate in designated staff development

activities. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job-related training from department supervisors and district representatives.

Instructional Materials

All textbooks used in the core curriculum at Valley View Elementary School are aligned to the California Content Standards and Frameworks. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's six-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, September 13, 2011, the Pleasanton Unified School District's Board of Trustees held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Trustees adopted Resolution No. 2011.12.01 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2011-12 school year, Pleasanton Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. These materials complied with the state's content standards and curriculum frameworks.

School Leadership

Valley View's principal, Rafael Cruz, is responsible for the day-to-day operations of the school and the overall instructional program. Principal Cruz works closely with Valley View's Leadership Team, comprised of grade level representatives, to fulfill the many responsibilities associated with running an effective academic program and to address the needs of the students, staff, and the school at large. The Leadership Team

meets monthly throughout the school year to discuss school programs, the learning environment, staff development needs, and other related issues that impact student learning and campus climate. The team works collaboratively to create and implement solutions.

Principal Cruz has served Valley View Elementary School since 2009-10.

Professional Staff

Counseling & Support Staff

Valley View Elementary School provides professional, highly qualified staff that provide additional services and support centered on the whole student academically, physically, and mentally. The Counseling and Support Services table in this report illustrates the availability of non-instructional support staff to Valley View Elementary School's students. Full-time equivalent (FTE) is a standard measurement used to identify an employee's regular work load on a weekly basis. For example, an FTE of 1.0 designates a full-time position and the employee is on campus and available all day every day of the week; an FTE of 0.5 indicates that the staff member is available and on campus a portion (50%) of the week.

Teacher Assignment

During the 2010-11 school year, Valley View Elementary School had 36 teachers who met all credential requirements in accordance with state guidelines. The Federal No Child Left Behind Act requires that all teachers in core subject areas meet certain requirements in order to be considered as "NCLB Compliant." Minimum qualifications include: possession of a bachelor's degree, possession of an appropriate California teaching credential, and demonstrated competence in core academic subjects. In the table below, which identifies the number of classrooms taught by NCLB-compliant and non-compliant teachers, high poverty schools are those schools in the highest quartile for student participation defined by the free and reduced price meal program. Low poverty schools are those schools that are in the lowest quartile of program participation.

Expenditures Per Student

For the 2009-10 school year, Pleasanton Unified School District spent an average of \$7,599 of total general funds to educate each student (based on 2009-10 audited financial statements and in accordance with calculations defined in Education Code §41372).
