Instruction

High School Graduation Requirements

The Governing Board desires to prepare all students to obtain a high school diploma to enable them to take advantage of opportunities for postsecondary education and/or employment. Students shall receive diplomas of graduation from high school only after completing all requirements. Youth in foster care, children of military families, and special education students identified through their IEP, may be eligible for specific waivers from the district's graduation requirements. Students shall complete the following requirements in order to receive a diploma of graduation:

- 1. Total credits required: 220 (Including 155 credits from required courses; students may earn a maximum of 40 credits per semester.)
- 2. Required courses:

(One year = 10 credits)

High School Graduation Requirements (continued)

- 3. Complete four years of high school
- 4. Pass the California High School Exit Exam (CAHSEE) in both language arts and mathematics, unless the student receives a waiver or exemption. (Education Code 49701, 51225.3, 60851, 60859)

The Superintendent shall ensure that parents are properly notified of progress towards graduation and will establish procedures for parent involvement and consultation in instances where a student has not met the credit, course, or High School Exit Exam requirements.

Alternative Education Options to Achieve Graduation

The Governing Board recognizes the need to provide opportunities for Alternative Education programs as part of the district instructional programs.

Alternative Education programs will provide alternative means for students to complete the prescribed course of study to graduate from the Huntington Beach Union High School District. These alternative means will include the same course outcomes per district standard.
